- All prior season balances including penalty and interest must be paid in full before your new application is processed.
- If **shareholder** membership fees are not paid in full by March 1<sup>st</sup>, all shareholder membership fees shall be increased by 10%
- Owners have priority over seasonal members regarding assignments for bathhouses, cabanas, and apartments.
- The Galilee Beach Club is not responsible for items left at the club.
- **Billing** will take place on the 15<sup>th</sup> of the month. **THESE ARE DUE AND PAYABLE UPON RECEIPT!**  
If the Association does not receive your remittance, you will receive a notice with a \$50.00 late fee plus 1.5% interest per billing cycle.

The notice will also advise you that your account is delinquent and that all membership privileges have been terminated until full payment is received or until acceptable terms are granted by the Board of Directors - **NO EXCEPTIONS.**

These policies are necessary in order to meet the Galilee Beach Club Association's cash flow requirements. If the Association needs to go to court to collect unpaid charges, the member is also responsible for any legal fees the Association incurs during this process.
