- **Memberships** are not official unless signed by the applicants (husband & wife) and accepted by GBCA.
- The Galilee Beach Club is not responsible for items left at the club.
- **Shareholders have priority** over Seasonal members regarding assignments for bathhouses, cabanas, and apartments. If the Association does not receive your NON-REFUNDABLE cabana deposit by December 15, you will be removed from the cabana list and your cabana will be reassigned.
- **Billing** will take place on the 15th of the month. **THESE ARE DUE AND PAYABLE UPON RECEIPT!** If the Association does not receive your remittance, you will receive a notice with a \$50.00 LATE FEE PLUS 1.5% INTEREST PER BILLING CYCLE.

Shareholders: If your cabana membership is not paid in full by March 1st you lose the 10% shareholders discount included in the rates given and you have 30 days to pay the balance. If after 30 days, your outstanding balance has not been paid in full your cabana will be reassigned.

The notice will also advise you that your account is delinquent and that all membership privileges have been terminated until full payment is received or until acceptable terms are granted by the Board of Directors - **NO EXCEPTIONS.**

These policies are necessary in order to meet the Galilee Beach Club Association's cash flow requirements. If the Association needs to go to court to collect unpaid charges, the member is also responsible for any legal fees the Association incurs during this process.
